How to Register

PARENT/GUARDIAN INFORMATION

Mail-In

- All Mail/Fax-In Registration begin Monday, June 2, 2008.
- Fill out mail-in registration form completely and make check payable to City of Fountain Valley.

Walk-In

- Begins Monday, June 9, 2008 at the Recreation Center, 16400 Brookhurst Street or at the Senior & Community Center, 17967 Bushard Street.
- We now offer paying by Credit Card: Master Card, Discover & VISA only. There is a 2.5% fee that will be assessed to each charge. In addition, we will continue to accept checks, exact cash or money orders.
- All classes are on a first-come, first-served basis.

General Policies

- No registrations taken at class.
- Program information may be subject to change.
- A \$5 fee will be charged for each transfer.
- A \$25 fee will be charged for returned checks.
- Class fees not prorated.
- Participant registration cannot be transferred to another class.
- Classes will be cancelled if minimum is not met.

Refund Policy

- All refunds must be in writing and must be received prior to the second class meeting and then a \$5 administrative charge will be assessed for each refund.
- All camp refunds must be in writing. A minimum of 1 week notice given for a refund and a \$10 fee will be charged. A \$5 fee will be assessed for all transfers. No same week refunds will be accepted.
- If the class is cancelled by the Division, an automatic refund will be processed and mailed to you.
- Participant will be charged for classes attended.

Late Registration

- Registration will not be accepted after the second class Meeting.

Class # & Session:

Include a six-digit class # plus a session # (session # includes a letter of the alphabet)

Self-Defense & Self-Awareness

This program combines safety awareness education with self-defense instruction in a fun, structured environment! Students are placed into classes according to age and ability. Students learn and practice verbal and physical skills for self-defense against "Bullies" and "Strangers". Course content includes: Break-away, techniques for close contact (being grabbed), communication skills and confident posture. Weekly safety awareness information addresses the lure strangers use to attract and abduct children and teens. Students progress in rank and earn their belts! It's only \$6 per lesson if you pay in full for the entire 8 week session (\$48), or \$7 if you pay weekly. There is a \$6 material fee for each student paid once per session, payable to Young Champions. Registrations are taken up to the 3rd week of class.

Refund requests must be in writing and will only be granted prior to the second class meeting and participant will be charged for classes attended. No refunds will be granted after the second class meeting. All camp refunds must be in writing. A minimum of 1 week notice given for a refund and a \$10 fee will be charged. A \$5 fee will be assessed for all transfers. No same week refunds will be accepted.
