Chair Cameron opened the public hearing. Assistant Planner Matt Jenkins presented the staff report and answered questions from Commissioner Blake regarding the recent off sale approval of Chevron across Magnolia on the southwest corner. Mr. Jenkins stated Chevron is in a different census tract and explained off sale permits allowed in the area. The applicant Ahmad Ghaderi was available and answered questions from commissioners regarding company training and security. Jorge Parra, Director of Operations discussed the corporate store. With no one in the audience wishing to speak on this item, Chair Cameron closed the public hearing.


